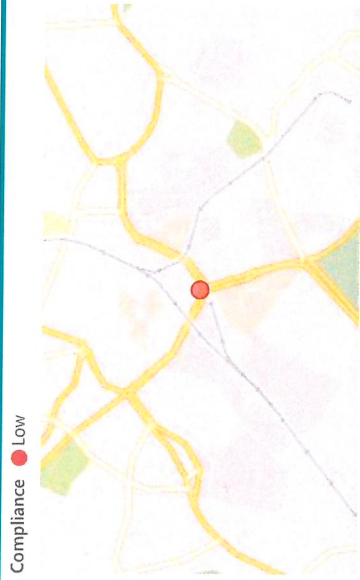


Local Offer SEN Support Analysis
