## General Considerations

Partial

1 - Easy to navigate, however does not clearly signpost Offline Local Offer Resources.

Yes

2 - Clear evidence of feedback and "you said we did". Signposting to offline groups included "Halton SEND Carer's forum", and "INVOLVE".

3 - Unable to find in the stated timeframe.

Partial

4 - Graduate Approach currently under review for EY and Schools. However Best Practice: includes an easy flowchart with information on requesting an EHC Assessment process, including the right to appeal.

5 - Clearly signposted factsheets including those aimed at Young People.

## EY Specific Considerations

Yes

1 - LO lists all EY SEN providers, and links to a SEND information report. This standard report includes all relevant information including cost, accessibility, and contact details for the provider in question.

2 - n/a

Partial

3 - LO links to a document which outlines the need for continual review of EY development, and provisions to be made accordingly. However explicit reference to 2 and 3 is not made.

## School Specific Considerations

Partial

1 - LO lists the providers available, and their SEND information Report, however does not provide further information, nor a clear to use search function.

2 - General information regarding the SEN Support in schools specifically.

Partial

3 - Again, the LO contains reference to external documents e.g. "Leaving school - what next?", however contains limited information on the LO itself.

Additional Comments: 4 - LO contains multiple external links however very little clear guidance as to the offers.

## Post-16 Specific Considerations

Partial

1 - LO contains information of post-16 providers. However information is drawn from a third party (and not endorsed by the LA). Information is also more limited (and harder to navigate) than in other LOs.

Partial

2 - LO contains information relating to the Youth Offending Service (YOS), which is shared between Cheshire West, Halton and Warrington. However information relates to national LA provision, as opposed to specialist provision, as opposed to specialist information relating to the offers.

Additional Comments: 4 - LO contains multiple external links however very little clear guidance as to the offers.
