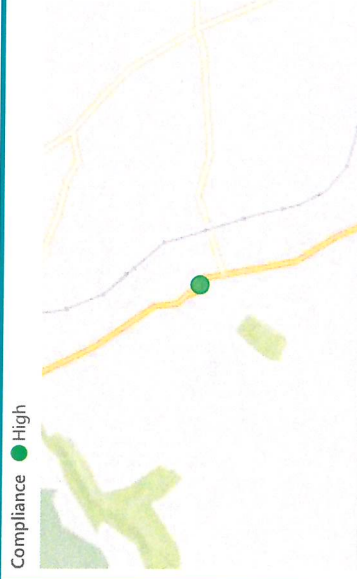


Local Offer SEN Support Analysis

General Considerations

Partial

- 1 - Contains a "What is the Local offer" section, however does not signpost offline resources.
- 2 - Best Practice of Feedback Forms & "you said we did". Also includes signposting to events such as "regular parent/carer groups", for offline views to be given.
- 3 - "Arrangements for Top-up funding and educational placements".
- 4 - Clear detail regarding the pathway for requesting assessment, and the graduated response.
- 5 - Clear detail around dispute resolution services - mediation & NT

Additional Comments: 6 - Links to Sign language version of LO (produced jointly with Lancashire Deaf Services (LDS), to improve overall accessibility.

EY Specific Considerations

Yes

- 1 - LO contains a list of EY providers and their contact details, including eligibility & Ofsted inspection data.

2 - n/a

- 3 - LO contains information relating to the roles and responsibilities of providers. LO also outlines the need for reviewing as part of the graduated approach. However explicit reference to 2 & 3 yr old reviews are missing.

Additional Comments: 4 - n/a

School Specific Considerations

Yes

- 1 - LO contains clear information regarding mainstream and specialist schools, and the reasonable adjustments required. LO signposts to "change in provision requests".

- 2 - LO clearly links to documents outlining what is expected from schools regarding SEN support.

- 3 - Application information for Post 19 institutions is clearly signposted. Unable to find post-16 application advice.
