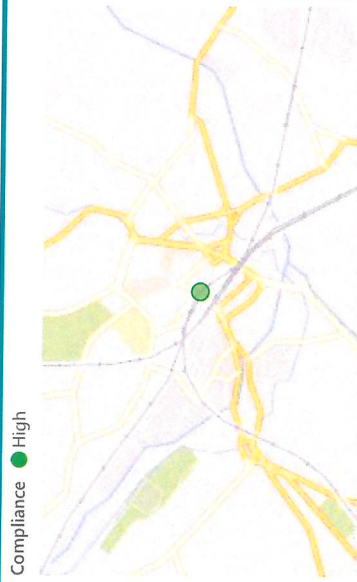


Local Offer SEN Support Analysis

General Considerations

Partial

1 - Information is easy to navigate, however does not signpost to offline resources.

4 - Information regarding requesting an assessment and the graduated approach is clearly demonstrated.

5 - Information is available regarding disagreement resolution services, however not as clear as other LOs.
